Standard prevention suggestions from the CDC

- Avoiding close contact with people who are sick;
- Staying home when you are sick and avoiding contact with persons in poor health;
- Avoiding touching your eyes, nose and mouth with unwashed hands;
- Covering your cough or sneezing into a tissue, then disposing of the tissue;
- Washing your hands often with soap and water for at least 20 seconds, especially after going to the bathroom, before eating, after blowing your nose, coughing or sneezing;
- If soap and water are not readily available, use an alcohol-based hand sanitizer with at least 60% alcohol. Always wash hands with soap and water if hands are visibly dirty; and
- Cleaning and disinfecting frequently touched objects and surfaces using a regular household cleaning spray or wipe.
- Avoid gatherings of 10 or more people

Information from the Courts

- All jury trials are suspended from March 16 through March 27.
- Speedy Trial time limits are suspended during this time.
- All rules limiting the use of communication equipment to conduct hearings are suspended during this time
- Judges allow inmates to appear by videoconference from the jail in all proceedings whenever possible.
- Judges allow the presence of Defendants to be waived, whenever possible.
- Judges, Court Staff, Clerks of the Court, and Court Security jointly develop a plan for the handling of any mass dockets for which they are responsible, which allows for the separation of those waiting to be heard into smaller groups through the use of additional "waiting courtrooms" or hallways.

Update from the School Board

The Florida Department of Education (FLDOE) has directed all districts to develop plans to serve students in the event that normal school operations are not resumed after spring break. FLDOE has named these Instructional Continuity Plans.

All staff shall report to their regular worksite on Thursday, 3-19-20 in order to work on this plan, and on school cleaning. Normal work hours will be followed for this date. The School Board of Levy County is working with the Levy County Department of Health to complete both a comprehensive cleaning of all school sites, as well as ongoing cleaning practices designed to reduce the risk of viral spread. Principals may make adjustments to this schedule as needed.

Food Service

The School Board of Levy County will provide meals at no cost to all <u>children 18 years of age and under or to Students</u> with Disabilities 21 years of age and under. This includes children attending private school, charter or home schools. Food distribution in bags consisting of breakfast and lunch meals for five (5) days will be delivered to all current bus stops this Thursday, (3-19-20), between the hours of 10:00 AM and 2:00 PM. The District will attempt to call parents at each stop before the bus arrives. This will not continue during the pre-existing Spring Break (03-23-20 to 03-27-20). Additionally, meals for children 18 and under will be available for pick up in the parent loop on the same day between the hours of 10:00 AM and 11:00 AM at the following 5 locations: Bronson Elementary School, Chiefland Elementary School, Williston Elementary School, Cedar Key School and Yankeetown School. Again, this will not continue during the pre-existing Spring Break (03-23-20 to 03-27-20).

If normal school operations do not resume after Spring Break, plans will be developed to extend these services.

Report Cards for the 3rd 9-Weeks

Individual schools will send out messages to parents regarding availability of report cards for pickup. Skyward will be available for parent access to current grades and attendance as well.

Update from the Sheriff's Office

Sheriff McCallum along with members of his command staff were involved in multiple briefings today as they relate to the COVID - 19 virus. Currently there are no confirmed reported cases of COVID - 19 in Levy County but all preparations to prevent the spread of this virus are being taken to ensure the public's safety and the safety of those in custody.

Based on information obtained during these meetings Sheriff McCallum has decided, in the abundance of caution, to suspend all ON-SITE visitations with persons in the custody of the Levy County Detention Facility. Family and friends of individuals in custody are still able to contact loved ones by phone and on-line video visitation.
